Cancellation Policy

There will be a \$500.00 cancellation fee in addition to any remaining balance on an athlete account for anyone who does not fulfill this contract and complete the ENTIRE season. If an athlete decides to quit the program, they are responsible for ALL fees for the remainder of the season in addition to the Cancellation fee of \$500.00.

Policies and Expectations

It is our desire as a family to treat others how you expect to be treated. The Legacy Athletics program is one of integrity and commitment. We expect our athletes to conduct themselves in a way we can all be proud. The use of foul language in the gym, gossip, physical confrontations, and lack of respect for our fellow teammates and coaches/staff will not be tolerated. This includes negative comments and/or gossip amongst parents as well. Again, we are a team and as stated above consider our program family; we will not tolerate such behavior.

Practices may be changed or added at any time during the season, typically when getting ready for competition. You are agreeing that you will comply to schedule changes without complaint. This is a highly competitive program that demands attendance of all kids on the team.

Never post any negative comments about any athlete, team, or our program on any websites or social media pages.

No negative talk about our Legacy Coaches, Staff, Athletes or Parents. If you have an issue with the way your child is being taught, please contact us via phone or email to set up a meeting to address the issue. However, you are entering into a contract whereas you are trusting the Legacy Athletics staff to train your child the way we believe in.

- There will be no arguing with or questioning a coach's decision. We will always have the athlete and LEGACY ATHLETICS best interest at heart.
- Please do not bring or leave valuables in the gym. We are not responsible for unattended items and will not held accountable for something your child lost.
- No one can make any items such as clothing and accessories with the "Legacy Athletics" name or logo on it without our approval of the design or business you will be using. **If we see any attire not purchased through Legacy Athletics with the logo or gym name printed on it, there will be a \$50.00 fee automatically charged to your account.** The second time will result in a \$100.00 fee automatically charged to your account. If this happens a third time, we will ask that you no longer be a part of LEGACY ATHLETICS due to not upholding our rules.
- The inability to comply with any of these Policies and Expectations may result in dismissal from your team with no refund for the year.
- If an Athlete is dismissed from the program, they are still required to uphold our cancelation policy.
- Legacy Athletics has the authority to close practices at any time throughout the season as they see fit. If we choose to close practice, there will be no rebuttal. Once we say it is closed, it is closed. You are agreeing to this being a possibility throughout the season.

Tardiness and Absences

- It is our desire to be successful in every aspect and to keep every athlete safe. This can ONLY be done through your commitment of satisfactory attendance. For your child's safety first and foremost it will be crucial for parents to refrain from talking over the wall/door while your child is in practice. Because ALL-STARS is a group of individuals coming from different schools, each student and family must understand the commitment involved both socially and financially. Attendance is crucial to succeed. Please understand that when one child misses it limits practice as a group. Being successful means making attendance your top priority to the team.
- We at Legacy Athletics understand that extenuating circumstances will come up during the season so, we allow 3 unexcused absences for the ENTIRE season. After 3 unexcused, we reserve the right, in the best interest of the team to change the routine if need be. This includes but not limited to changes in placement or replaced by an alternate.
- **Failure to contact a coach about missing practice for any reason will result in an unexcused absence.**
 - You are considered tardy to practice if you are not on the practice floor ready to practice when your designated time starts. This includes having shoes on and extra clothing off.
- Unexcused absences from a competition will result in immediate dismissal from your team with NO refund. All absences must be cleared in advance with your all-star coaches.

- The only form of excused absences other than pre-approved are ones accompanied by a Doctor's note.

Injuries and Conditioning

Parents need to note that cheerleading is a highly competitive and physical sport and the skills involved such as stunting, jumping, and tumbling could lead to injuries. These include but are not limited to bruises, pulled or strained muscles, torn or strained ligaments, broken bones, dislocations, etc. Legacy Athletics will take every precaution to prevent these injuries. Unfortunately, we cannot prevent all injuries. If your child is injured, we will take every necessary step to ensure your child's well-being. You are agreeing that Legacy Athletics will not be held responsible in the event of injury within our facility. We will also be conditioning our athletes. **No child will be exempt from conditioning/stretching.**



Statement of Financial Commitment

I have read and fully understand my financial commitment to Legacy Athletics which is outlined in the evaluation packet. I understand that I will be responsible to pay for the full 2020-2021 season regardless if I choose to leave a team or if I am asked to leave the program due to attendance or any disruptive behavior, in addition to the cancellation fee of \$500.00. I understand that I am entering into this program at my own free will and that any unpaid amounts will be turned over to a Collection Agency and may negatively affect my credit score.

1. A member and a member's family must at all times be a strong representative of Legacy Athletics All Stars and a positive reflection of their team.
2. Abusive behavior, lying or any other form of negative behavior by a parent or child is grounds for removal from the team.
3. No athlete shall drink alcohol or use any form of drugs including cigarettes or Vaping, while in Legacy Athletics attire or at a Legacy Athletics function. *You will be subject to immediate removal.*
4. Many people communicate with other parents, cheerleaders and members of other organizations through email, Facebook, Twitter, and message boards. Please remember, anything you say is a direct reflection on Legacy Athletics.
5. ***Social Media may not be used as your personal weapon. If you are found communicating negatively or sending rude or inappropriate messages, you will be subject to immediate removal.***
6. Upon entering and exiting Legacy Athletics and while attending competitions, all athletes must be wearing appropriate attire; sports bras, uniform half tops and any other revealing attire must be covered by a t-shirt or sweatshirt.
7. When informed of travel schedule, coaches will explain departure dates and arrival times. It is expected that these dates and times are adhered to and all athletes are at practices prior to competition. We will notify you in advance if we are adjusting travel dates.
